7. Direct board and members to delete/refrain any/all posting of social media comments and videos referencing me (Stanley Ford), in particular, disparaging me and my character, within the by November 12, 2025.
8. I will provide a Certified Check drawn from Truist Bank/Lumbee Guaranty Bank to Ms. Charlisa Davis (VP FCCMLK).
